Through a mobile surgery clinic that travels statewide and a stationary clinic in North Minneapolis, MN SNAP has completed more than 197,000 surgeries since 2010 in partnership with low-income families, nonprofit rescues and shelters. These efforts keep pets in their loving homes and aid in the management of community cat populations throughout Minnesota.

Headquartered in North Minneapolis, and partnering with dozens of communities in all parts of the state, we actively support a diverse clientele and are seeking individuals dedicated to fostering inclusivity within our organization and serving racially and socioeconomically diverse communities.
